

## Notice of Change of Possession of Aircraft

(Where both the person(s) relinquishing possession and the person(s) taking possession of an aircraft are both available). This form is used to notify the CAA of a change in possession of an aircraft, under Part 47 of the Civil Aviation Rules and to seek the grant of a new Certificate of Registration. Please ensure that the form is complete and the fee of \$263.00 has been paid. Incomplete or unpaid applications will not be processed and may cause delays in the change in registration while follow up information/fee is sought. This could affect putting the aircraft on an Air Operator Certificate. The fee is the responsibility of the relinquishing party unless otherwise agreed between parties. For more information see Advisory Circular AC47-1.

### Instructions for completing this form

Please ensure all sections of this form are completed and the change of possession fee of \$263.00 (including GST) has been paid to the CAA. This fee is the responsibility of the person relinquishing possession of the aircraft unless otherwise agreed between the parties. **Payment can be made by credit card or direct internet banking.** 

A Fit and Proper Person Questionnaire CAA 24047/02 (available on the CAA website) must also be completed and submitted by the new owner if they do not have a recent Fit and Proper Person history with the CAA. (This could be by being an existing aircraft owner, or having an aviation document issued within the last five years.)

NOTE: The completed application form and payment must be received by the Civil Aviation Authority within 14 days of the transfer of possession. See the requirements under Rule §47.57 and Advisory Circular 47-57(b)(1).

#### Privacy statement for the purposes of principle 3 of the Privacy Act 1993:

The CAA is collecting information on this form about you to process your application for a Certificate of Registration for an aircraft. Information you provide may also be used by the CAA for wider aviation safety and security regulatory purposes. The information contained in this form will be held by the CAA and entered into the register of civil aircraft. A version of the register, which includes the name and postal address of an aircraft owner, appears on the CAA website, and is publicly accessible.

The information sought on this application form is required before a Certificate of Registration will be granted. If you do not provide the information, a Certificate of Registration will not be granted. In the case of a change of possession, the change of ownership may not be processed, and the aircraft's registration may be cancelled.

You may request access to and correction of personal information supplied on this application form, using the contact details <u>info@caa.govt.nz</u> or <u>privacy@caa.govt.nz</u>. At any time in future you are also entitled to:

- obtain confirmation whether or not personal information is held about you; and, if so:
- obtain access to that information, subject to the provisions of the Privacy Act 1993;
- request that CAA correct any personal information it holds about you.

#### When should this form be used?

This form is to be completed by both the person(s) relinquishing possession and the person(s) taking possession of an aircraft for 28 days or more. Alternatively you may use the reverse side of the Certificate of Registration which has a change of possession form printed on it.

Section 2 of the Civil Aviation Act 1990 defines "owner" of an aircraft to be the person lawfully entitled to possession of the aircraft for 28 days or longer. Although the Act and Rules refer to owner, a Certificate of Registration is not legal title – the registered operator is the person who is responsible for the operation of the aircraft, and to whom safety information is sent. It is the "owner's" responsibility under the Act and Rules to notify the CAA of any change in possession that would require a change in the registered owner of the aircraft.

Where there is more than one owner/operator you will need to decide who will sign the form and become the main contact for the CAA. In the case of partnerships and syndicates the CAA requires the full names, addresses, contact numbers and CAA client numbers (if applicable) of all members and a completed Fit and Proper Persons Questionnaire (24047/2) completed by each member.

If the person(s) relinquishing possession (seller) is unavailable to complete the form the person taking possession (buyer) will need to complete a different form CAA 24047/03A.
